Resolution # 01-2-A

A RESOLUTION OF THE BOROUGH OF CHESTER HEIGHTS, DELAWARE COUNTY, PENNSYLVANIA, AUTHORIZING BOROUGH COUNCIL TO ESTABLISH A FEE SCHEDULE FOR BUILDING & ZONING PERMITS.

WHEREAS, the Borough has established a fee schedule for building & zoning permits within the Borough; and

WHEREAS, by the Building Code of the Borough of Chester Heights, as amended on MAY 25, 2004 by adoption of the Pennsylvania UCC, the Borough of Chester Heights fixed by resolution the amount of fees paid for building permits; and,

WHEREAS, the Building Code Official has recommended to Borough Council that the fees be amended; and

WHEREAS, Borough Council accepts the recommendation(s) of the Building Code Official and the fee schedule contained therein, subject to subsequent modification by resolution of Borough Council;

Therefore, be it resolved, that the Borough of Chester Heights Schedule for Permit Fees, shall be established, effective this date as follows:

There shall be a minimum fee of **\$125.00** for any Building Permit Application, unless otherwise stated herein.

The mandatory PA State Surcharge of \$ 4.00 for all permits issued shall be added to the cost of each Building Permit Fee. An administrative fee of \$1.00 will also be added making the UCC fee a total of \$5.00.

All Building Applications (excluding all non-reviewable permits, see below) shall be subject to a Zoning Review pursuant to the Zoning Code of

The Borough of Chester Heights, the fee of which shall be **\$ (\$100.00)**

Duplication of Issued Permit: \$10.00.

Inspections, Re-Inspections, Return for Un-Prepared Inspections:

All inspections require a minimum 48 hours notice. In addition to the established fees listed below and in other resolutions, should the Code Official be required to re-inspect code related construction and/or violations, the Building Permit Application shall pay the following additional fee(s) of: **\$75.00 for each such inspection.**

Preliminary Plan Review: a fee shall be charged for each set of plans submitted for a "preliminary plan review". This review would not constitute "final" project code

compliance, but only as an overview of the scope. It may include one evaluation meeting to discuss project particulars:

Use Group R-3, less than 400 sq ft:	\$ 75.00
Use Group R-3, greater than 400 sq ft:	\$ 150.00
Use Group R-2, less than 10,000 sq ft:	\$ 500.00
Use Group R-2, greater than 10,000 sq ft:	\$ 750.00
Use Group R-1, less than 10,000 sq ft:	\$ 500.00
Use Group R-1, greater than 10,000 sq ft:	\$ 750.00
Other Use Groups:	
Up to 5,000 sq ft:	\$ 500.00
5,001 sq ft to 10,000 sq ft:	\$ 750.00
Greater than 10,000 sq ft:	\$ 1,000.00

Use & Occupancy Certificates:

For Residential, no additional fee

For all other Use Groups; Certificate of Use: \$80.00, Certificate of Occupancy: \$125.00.

Re-Funding of Permit Fees: Any request for refund of fees must be made in writing and addressed to the attention of Building Code Official, no later than six months from the date of payment of issuance or permits, whichever is longer.

Any request past the six month period shall not be accepted.

Any administrative cost fee of 35% shall be deducted from the original fee amount requested.

A. Residential: the value on which fees shall be computed based on the following methods. The permit fee shall be a multiplier of **0.0065** times the total estimated value in dollars:

All Structures: \$ 150.00 up to \$500.00, \$15.00 each \$ 500.00**

Residential Re-Roofing: in excess of 25% of the existing roof:

All Structures: \$ 125.00 up to \$1000.00, \$10.00 each \$1,000.00**

Residential: Swimming Pools: equal to or greater than 24 inches deep:

In-Ground: \$ 500.00

Above-Ground: \$ 75.00

B. Commercial: Fees shall be based on the owner-submitted Contract or a reasonable cost estimate, by not less than the applicable estimated construction “worth” indices provided by “Means” 2005 or latest edition:
