Inspector's Reports

Building Inspector - No Report

Richard Jensen

Fire Marshal - Fire Marshal Ciocco reported on the 2020 year in review themed "Safety in the Kitchen": Mike Ciocco Fire Statistics are as follows:

- 1. Forty-Nine percent (49%) of home fires start in the kitchen. The main reason is unattended cooking
- 2. Fifteen percent (15%) of home fires are attributed to heating. These includes main house heaters, fireplaces, and space heaters
- 3. Ten percent (10%) of home fires were credited to electrical. These include electrical outlets, small appliances, and lighting fixtures
- 4. Five percent (5%) of home fires are charged to smoking. These include cigarettes, cigars and inhaling devices
- 5. Two percent (2%) of home fires result in candle burning. The bedroom is the area most associated with candle burning

The response of the public's willingness to adopt Fire Safety in their daily lives is always a challenge. There were fifty-five (55) incidents this year. This is down from sixty-three (63) last year. This was an 8.7% decrease in incidents. Analysis of investigations revealed AFA's (automatic fire alarms), storms, workmen and faulty devices. The increase of false alarms included pull station activations, elevator entrapment and faulty sprinkler equipment.

Budgetary guidelines were met this year. The main expenditures were dues to the National Fire Protection Association (NFPA) and reference books.

Review of Fiscal 2021 foresees some additional expenses or disbursements for the Fire Marshal's office. These expenses are earmarked for Fire Safety Public Awareness, office supplies, dues, and subscriptions. A total of \$1,000.00 is requested for FY 2021.

EMC Ward reported on December 24th, 2020 a wind and rainstorm caused trees to come down on Valleybrook and Wawa Roads, Baltimore Pike was closed for several hours. The Chester Heights Fire Company worked until about 2:00 a.m. to keep roads passable for emergency vehicles. PennDOT and PECO were notified, as necessary. The Fire Company also responded to a house fire in Middletown Township caused by a candle, due to electricity being out from the storm.

Present Baum asked for an update on the first snow event of 2020. Roadmaster Ward reported that this was the first snow event (with accumulation) in the past couple of years. There were a few issues which needed attention. A couple of driveways needed to be marked for future snow events but mostly everything went smoothlyyyyy and roads were cleared.

Solicitor Montella presented the adoption of Resolution 1-21-A:

Resolution 1-21-A

A Resolution of the Borough of Chester Heights, appointing a Zoning Hearing Board Member: WHEREAS, The Municipalities Planning Code, 53 PS 10901 et seq, directs that Borough Council shall appoint, by resolution, a registered elector of the Borough as a Zoning Board Member when a vacancy

occurs on the Zoning Hearing Board: and

WHEREAS, Cynthia A. McNicholas, Esq, served with distinction on the Zoning Hearing Board for many

years and resigned her position effective December 31st, 2020; and

WHEREAS, Council appoints, after thoughtful consideration, Natalie R. Young, Esq, a registered elector of the Borough holding no other elected or appointed office in the borough and who is not an employee of

the borough; and

NOW, Therefore, Be It Resolved, this 4th day of January 2021 that Natalie R. Young, Esq, be and is hereby appointed to serve as a member of the Zoning Hearing Board, to fill the vacancy created by the resignation of Cynthia A. McNicholas, Esq effective December 31st, 2020 and shall serve in such appointed position until the portion of the unexpired term.

MOTION

Upon Motion, Council (Baum.Clarke) voted and unanimously approved the adoption of Resolution 1-21-A. A Resolution appointing Natalie R. Young, Esq., on January 4th, 2021 to fill the vacancy created by the resignation of Cynthia A. McNicholas, Esq effective December 31st, 2020 and shall serve in such appointed position until the portion of the unexpired term.

Solicitor Montella presented the Addendum to Lease Agreement requesting a Motion:

Addendum

This Agreement, is made this 4th day of January 2021, by and between the Borough of Chester Heights, a Municipal Corporation organized and existing under the laws of the Commonwealth of Pennsylvania, (hereinafter called the "Tenant"), and Chester Heights Fire Company No. 7, a Pennsylvania non-profit organization, (hereinafter called the "Landlord").

WHEREAS, the Landlord and Tenant executed a lease agreement wherein the Tenant leased certain office space from Landlord for a term of five (5) years beginning February 1, 2017; and WHEREAS, the lease agreement was fully executed in 2017; and

WHEREAS, the term of said lease was intended to terminate five years from February 1St, 2017 or at 11:59 pm on February 1st, 2022; and

WHEREAS, the ending lease date in Paragraph 1 is incorrectly identified as February 1st, 2021; and WHEREAS, both Landlord and Tenant agree the lease ends at 11:59 pm on February 1st, 2022 which Is a five (5) year term; and

NOW, therefore, the parties mutually agree:

The lease agreement executed between the parties, attached hereto, ends at 11:59 pm on February 1st, 2022 and Paragraph 1 TERM is hereby amended as described herein.

MOTION

Upon Motion, Council (Baum.Anderson) voted and unanimously approved the Addendum to the Lease Agreement. The term of said lease was intended to terminate five (5) years from February 1st, 2017 or at 11:59 pm on February 1st, 2022.

Solicitor Montella presented the adoption of Resolution 1-21-B:

Resolution 1-21-B

A Resolution approving the Final 2 Lot reverse subdivision/subdivision application (lot line change) of Rose Hill Developers, LP and Carol J. Fager for the property located on the northeast corner of Lenni And Llewelyn Roads, Borough of Chester Heights, subject to conditions.

WHEREAS, the purpose of said Plan is to subdivide off a small parcel of the larger Rose Hill School Tract, and to consolidate the subdivided parcel identified on the Plan as Lot 1 with the property formerly known as the William and Carol Fager Property located along the northeasterly side of the Rose Hill Tract which is shown as Parcel A on the Plan; and

WHEREAS, the Borough Engineer reviewed the revised Final Reverse Subdivision/Subdivision Plan for Rose Hill Developers L.P. and issued a second review letter which is dated November 20th, 2020, which indicated that the comments contained in his previous review letter have been satisfactorily addressed and that the four concrete survey monuments outlining the new perimeter of the "Fager" lot have been set and recommended that Borough Council can take action on the Minor Subdivision/Reverse Subdivision Application conditioned on the plans not being released for recording until 1) the portion of the existing driveway on the conveyance parcel is removed; and 2) the two buffer trees located on the conveyed Parcel are planted; and

WHEREAS, said revised plans were further revised slightly on December 8th, 2020 and found to be satisfactory by the Borough Engineer.

NOW, Therefore, Be It Resolved, the Applicant, Rose Hill Developer's LP's, revised Final Reverse Subdivision/Subdivision Plan dated September 24th, 2020, last revised December 28th, 2020, is hereby APPROVED as a final subdivision and reverse subdivision plan, subject to confirmation by the Borough Engineer that the conditions set forth in his November 20th, 2020 Review Letter have been satisfied, all of which has been agreed to by the Applicant and by Carol Fager.

MOTION

Upon Motion, Council (Lim.Anderson) voted and unanimously adopted Resolution 1-21-B. A Resolution, the Applicant, Rose Hill Developer's LP's, revised Final Reverse Subdivision/Subdivision Plan last revised December 28th, 2020, is hereby APPROVED as a final subdivision and reverse subdivision plan, subject to confirmation by the Borough Engineer that the conditions set forth in his November 20th, 2020 review Letter have been satisfied, all of which has been agreed to by the Applicant and by Carol Fager.

Engineer Houtmann reported on the sink hole issue at the Maddison Apt. inlet:

Engineer Houtmann contacted PennDOT office through email to address the issue of the sink hole in front of Maddison Apts. Engineer Houtmann received a letter from PennDOT stating the Borough is responsible for all underground stormwater issues on state roads.

Engineer Houtmann said he knows the information for cities to be true, and will need to research the State code for an answer. This will mean the Borough would be responsible for underground stormwater repairs for all state roads with the Borough boundaries. Solicitor Montella was asked to assist and research the issue.
