RESOLUTION No. 12-19-A

A RESOLUTION OF THE BOROUGH OF CHESTER HEIGHTS, DELAWARE COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2020

NOW THEREFORE, BE IT RESOLVED, by the Council of Chester Heights Borough, Delaware County, Pennsylvania:

THAT a tax be and the same is hereby levied on all real property within the Borough of Chester Heights, Delaware County, Pennsylvania, the tax rates being the same or decreased from prior year, subject to taxation for the fiscal year 2020 as follows:

SECTION 1. Tax rate for general purposes, the sum of .45 mills for each dollar of assessed valuation, or the sum of \$0.045 on each one hundred dollars of assessed valuation.

SECTION 2. Tax rate for Borough Fire Services tax, the sum of 0.40 mills for each dollar of assessed valuation, or the sum of \$0.040 on each one hundred dollars of assessed valuation.


SECTION 3. Tax rate for transfers of real estate within the Borough of Chester Heights, the sum of one-half of one percent (.005%) of the gross consideration for the sale of real estate being transferred.

SECTION 4. That any resolution, or part of resolution, conflicting with this resolution be and the same is hereby repealed insofar as the same effects this resolution.
