

Minutes of the 60th Meeting of The BOROUGH  
OF CHESTER HEIGHTS PA. COUNCIL HELD IN THE BOROUGH  
SCHOOL BUILDING MONDAY FEB. 11th 1952 at 8 P. M.

This meeting was called to order by President Breneman  
with all members present excepting Mr. Stromgren.

The Minutes of the January meeting were approved as read.

The Treasurers Report was approved and correspondence handled.

Burgess Schrader stated he thought the Borough boundary on  
Mattson Road was not clearly established and it was sug-  
gested he contact the Borough Engineer to obtain the location  
of the exact line. The Burgess also questioned the legality  
of the Ordinance amending the Borough Zoning Ordinance.

Mr. Buckley at this time requested that Council have the  
Borough Solicitor furnish a legal interpretation of this  
Ordinance. Upon motion, duly seconded, the Secretary was  
directed to communicate with Mr. Hamilton and request this  
interpretation.

Chief of Police John Voigt presented his usual report on  
police activities.

The next order of business was the adoption of the Budget  
for the ensuing year. President Breneman requested the  
Burgess and the various committee Chairmen to present  
their estimated expenditures for the coming year.

As the ten day period since the proposed Budget was advertised, has not elapsed, it was moved, seconded and unanimously approved to declare a recess until Monday Feb. 18th. 1952 at 8 o'clock P. M. at which time this meeting will re-convene.

MONDAY FEB. 18th 1952

The recess was declared over and the meeting called to order at 8 PM by President Breneman, with all members present excepting Mr. Kerns.

At this time Mr. John Voigt presented to Council, Mr. <sup>Hobough</sup> Hobart, who has recently moved into this Borough. Mr. <sup>Hobough</sup> Hobart proceeded to express his views and objections to proposed dog kennels in the vicinity of his home. This subject developed into a rather lengthy debate between the Burgess and members of Council on the Legal aspects of Ordinance #23 amending the Zoning Ordinance.

Upon motion duly seconded it was unanimously approved the Secretary request from the Solicitor, his legal opinion as to the effective date of Ordinance #23, which was adopted by Council on January 7th. 1952.

It was also moved, seconded and unanimously approved that the Secretary obtain at the same time, the Solicitors interpretation of Sec. 1007 of the Borough Code, pertaining to the proper procedure to be followed in presenting an ordinance to the Burgess for his approval.

Finally, at 9.25 , the President called for the 1952 Budget. Councilman Krebs presented and explained in detail, the proposed Budget as prepared by the Finance Committee.
