

MINUTES OF THE 85th MEETING OF THE BOROUGH OF CHESTER HEIGHTS
COUNCIL HELD IN THE BOROUGH SCHOOL BUILDING MONDAY MARCH 1st 1954 at 8 P M

With a quorum present, the meeting was called to order by President Breneman. The absentee members were Mr. Kerns, Mr. Krebs and Mr. Wood.

Also present for his first meeting with Council was Borough Solicitor Mr. John F. Cramp.

The Minutes of the February meeting were approved after correction noted whereas Mr. Hobaugh was appointed as a committee of one to investigate the present and future tax requirements of the Chester Heights School Board and report his findings to Council.

The Treasurers Report was approved as presented.

The Burgess reported as follows;

A letter from Mrs. M. D. Wood, directed to the Burgess, was read. The subject of this letter referred to the various names of the Borough roads and the confusion caused by the lack of proper signs designating the correct name of said roads.

Mrs. Wood stated the results of a private survey conducted by the residents of Wawa Road, also referred to as Station Road or Church Road. It is hereby requested that Borough Council officially designate this road as Wawa Road and grant permission to these residents to erect signs at each end of this road.

This matter was referred to the Highway Committee with instructions to conduct a survey of all Borough Roads to determine the correct names ^{of} these roads in order that proper signs may be erected.

Upon motion, duly seconded, it was unanimously RESOLVED that permission is hereby granted to the residents of Wawa Road to temporarily erect street signs as requested, until the survey by the Highway Committee shall be completed and the official names of all Borough Roads has been established.

Burgess Little presented a report from the Building Inspector calling attention to a violation of the Zoning Ordinance on the Tucker property. Mr. John Tucker explained that his father has temporarily leased an old building on his property to a contracting company and ^{it} was being used for truck repairing. As this appears to be a violation of the Zoning Ordinance, Mr. Tucker was directed to appeal to the Zoning Board of Adjustment for a ruling or a variance.

Director of Civil Defense, Mr. Hobough reported Civil Defense activities progressing satisfactorily.

Street Supervisor, Mr. John Voigt reported on the condition of the Borough roads and the amount of trash that he has been removing from same.

Mr. Voigt also reported that he has been unsuccessful in his efforts to have burned-out street lights replaced.

The Secretary was directed to communicate with the Electric Co. and if necessary, to withhold payment of monthly bill until satisfactory service is rendered.

Under unfinished business the old quarry property was again presented for discussion, As there has been no effort by the

owner to fence in this property as promised some time ago. Borough Solicitor Mr. Cramp stated he would personally inspect the property and then proceed with the necessary action.

There being no further business, the meeting adjourned.
