

MINUTES OF THE 126th MEETING OF THE BORO. OF CHESTER HEIGHTS COUNCIL
HELD IN THE BORO. SCHOOL BUILDING MONDAY JUNE 3rd 1957 AT 8.00 P. M.

The meeting was called to order by President Wood, with all members present excepting Mr. Jobson.

The minutes of the May meeting were approved with correction noted whereas Mr. Hobough was delegated to determine the responsibility on the maintenance of Wawa Station roadway.

The Treasurers report was approved as presented by Miss Dickson, There were no reports presented by the various committees.

Unfinished business;

A copy of letter addressed to Mr. Benj. Levin by Mr. Schroder, Secty. of the Zoning Board of Adjustment was read by President Wood. This is in regard to the application for a special exception for the Thornbrook Hills property by Mr. Levin and has been referred to the Solicitor.

New Business;

The next order of business was the consideration of the request of the Chamber of Commerce of Chester and Delaware County to adopt a resolution concurring in the resolution of The Board of Commissioners of Delaware County, designating the Chamber of Commerce, City of Chester and Delaware County, as the Industrial Development Agency in all matters relevant to and for all purposes of the Industrial Development Assistance Law.

Upon motion which was seconded, it was unanimously RESOLVED, That the Council of the Borough of Chester Heights concurs in Resolution dated April 23rd, 1957 of the Board of Commissioners

of the County of Delaware and hereby approved the designation of Chamber of Commerce, City of Chester and Delaware County as the Industrial Development Agency to represent the County of Delaware in all matters relevent to and for all purposes of the Industrial Development A ssistance Law.

A t this time, Mr. John McManus was introduced to the members of Council. Mr. McManus has purchased the property at Valley brook & Wawa Roads containing 12 acres adjoining St. Thomas Church. Mr. McManus stated he was about ready to start construction of a home for himself and also stated it was his intention to construct three custom built homes on two acre lots.

Mr. Hobough advised that the annual pole survey would be handled by the Highway Committee.

There being no further business, the meeting adjourned.

RESOLUTION OF THE (COUNCIL) OF THE (BOROUGH) OF Chester Heights CONCURRING IN THE RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF Delaware, PENNSYLVANIA, DESIGNATING Chamber of Commerce, City of Chester and Delaware County, (WHICH IS TO BE DESIGNATED INDUSTRIAL DEVELOPMENT AGENCY) AS THE INDUSTRIAL DEVELOPMENT AGENCY FOR THE COUNTY OF Delaware IN ALL MATTERS RELEVANT TO AND FOR ALL PURPOSES OF THE INDUSTRIAL DEVELOPMENT ASSISTANCE LAW.

WHEREAS, by Resolution dated April 23, 1957 the Board of Commissioners of the County of Delaware, Pennsylvania has designated the Chamber of Commerce, City of Chester and Delaware County, as the Industrial Development Agency to represent the County of Delaware in all matters relevant to and for all purposes of the Industrial Development Assistance Law; and

WHEREAS, the Chamber of Commerce, City of Chester and Delaware County may only act as the Industrial Development Agency for the County of Delaware upon concurrence in the above stated Resolution of the Board of Commissioners of the County of Delaware by the governing bodies of Cities, Boroughs, Towns, or Townships within the County having in the aggregate over 50 per centum of the population of said County; and

WHEREAS, the (Council) of the (Borough) of Chester Heights desires that the Chamber of Commerce, City of Chester and Delaware County act as the Industrial Development Agency for the County of Delaware, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED and it is hereby resolved,

Section 1. That the (Council) of the (Borough) of Chester Heights concurs in Resolution dated April 23, 1957 of the Board of Commissioners of the County of Delaware and hereby approves the designation of Chamber of Commerce, City of Chester and Delaware County as the Industrial Development Agency to represent the County of Delaware in all matters relevant to and for all purposes of the Industrial Development Assistance Law.
