Solicitor Daly provided information concerning the proposed agreements.

Council discussed various issues and concerns with the proposed agreements.

Council requested the treasurer to contact the Concord Township Sewer Department to obtain information with regards to the borough taking on the sewer bills for the Hollow at Fox Valley Condo Association in Chester Heights and the Wawa store. Solicitor Daly will provide council with some revisions to some of the proposed agreements prior to the next council meeting.

ENGINEER REPORT

President Council reported that she received a written report from Borough engineer:

301 LLEWELYN ROAD

The asbestos removal has been completed. The next step is to firm up proposals that were previously obtained for demolition of the house, garage and pool. The engineer will solicit quotes and will get three proposals. Once the quotes are received, they will be presented to Borough Council for action.

HIGGINS REPORT

The engineer reported he will review the Annual Traffic Signal Inspection Report and will coordinate with the appropriate council member on how to proceed.

ARBOUR SQUARE

The engineer reported he received the cost of improvements from the Westrum and he has advised Westrum there will be required additions to the estimate for landscaping. The Improvement Security Agreement will require an approved cost of "public" improvement estimate.

PennDOT ISSUES

The engineer is awaiting a response from PennDOT whether any PennDOT approval is required for the placement of a digital speed advisory LED sign on Valleybrook Road. The engineer will also address overlapping concerns with Higgins Report and the recent discussions with PennDOT concerning alterations or improvements at the various signalized intersections in the Borough.

INSURANCE UPDATE

Councilwoman Driscoll reported to council that she has provided Information to the current insurance company and has contacted another insurance company that was recommended by the Pennsylvania Association of Boroughs to obtain comparative prices.

The Worker's Company policy is due for renewal in February. The General Liability policy is due for renewal in March.
