Resolution # 01-22-B Solicitor Montella presented Resolution # 01-22-B: A Resolution to fill the Vacancy of Council:

Whereas, Council Member, David Firkser, an elected official after distinguished service to the Borough,

resigned on December 1, 2021 and;

Whereas, said resignation was formally accepted on December 27, 2021 by a majority vote of a quorum of Council as prescribed by law pursuant to Borough code, Chapter 9 Section 901 (a.1) (2) and; Whereas, Chapter 9, Section 901 (a) specifically requires that "If any vacancy shall occur in the office of ...member of council... by resignation ...the borough council shall fill such vacancy ...by appointing, by resolution, a registered elector of the borough, to hold such office, if the term thereof continues so long until the first Monday in January after the first municipal election occurring more than sixty days after the vacancy occurs, at which election, and eligible person shall be elected to the office for the remainder of the term."; and

Whereas, Councilman Firkser's term ends January 1, 2024; and

Whereas, said appointee, a registered elector of the borough, shall have resided within the borough continuously for at least one year immediately prior to his or her appointment; and Whereas, a duly advertised public meeting was held on Monday, January 24, 2022, thirty (30) days from the date said resignation was deemed accepted, pursuant to 1 Pa. C.S.A. Section 1908 related to computation of time, to appoint, by this resolution, a registered elector of the Borough to fill the recognized vacancy; and

Now, Therefore, Be It Resolved, by the Council of the Borough of Chester Heights, Delaware County that Robert Sacks is hereby appointed to fill the vacancy which currently exists on Council for a term consistent with Chapter 9, Section 901 of the Borough Code.
