Call to Order President Baum called the public meeting to order at 7:01 p.m. and led those in attendance in the reciting

of the Pledge of Allegiance.

Zoning Hearing Meeting Update for 725 Darlington Road: Solicitor Pete Rohana, Esq. reported:

The ZHB held a meeting on November 17th, 2020. The applicant wants, to house 13 disabled elderly residents, who require little supervision. The property at 725 Darlington Road includes what is called the "main house" and two cottages to be used for the proposed use which is currently being used as a bed and breakfast. At the meeting there was testimony from Glenn Mon, current owner of the property, one of the applicants Ms. Perry, and expert witness attorney who testified about the federal fair housing amendment act. The applicant's position is the residents are classified as disabled and the housing of these individuals falls under the federal fair housing amendment act which protect homes purchased and used for these purposes and operate in this manner. The question/conflict with what was proposed is the borough's ordinance describes what is considered to be a family with 2 unrelated persons, what was proposed was 13 persons. Many questions still need to be answered, with respect to the residents in the area. The next ZHB Meeting will be held on December 15th, 2020. Solicitor Rohana requested Zoning/Building Inspector Richard Jensen to review questions concerning water, sewer and fire access issues in case improvements/updates are needed to move forward. President Baum requested Solicitor Rohana to appear at the next ZHB Meeting for 725 Darlington Road on December 15th, 2020. Solicitor Montella thanked Solicitor Rohana for substituting for him on the day or the hearing.

Solicitor Montella presented a new agreement with Allen R. Strickler for Stray Dog(s) for the Chester Heights Borough and requested a Motion to approve terms of the 1 (one) Year Agreement. Start date January 1st, 2021 through December 31st, 2021. The contract would begin as the BVSPCA expires.

President Baum requested a Motion to authorize Solicitor Montella to cancel the current Animal Control contract with Brandywine Valley SPCA, on December 31st, 2020, with a cancellation fee not to exceed \$6.000.00.

Zoning Hearing Board – Letter of Resignation – Presented by President Baum:

Fred Hamel, Chair of Zoning Hearing Board received a letter of resignation from Cynthia A. McNicholas. President Baum requested a Motion to accept the resignation letter from Cynthia A. McNicholas: President Baum thanked Cynthia McNicholas for her years of dedicated servive on the Zoning Hearing Board.

Also announced was the vacancy on the Zoning Hearing Board. All interested residents are encouraged To forward letters of interest, including resume to the Borough office. Allowing a two week period prior to the Regular Council Meeting on December 7th, 2020.

Spotted Lantern Fly Update – Presented by Councilwoman Clarke:

Councilwoman Clarke hosted a visit from USDA on November 20th, 2020 from 9am through 12 noon. Two representatives from USDA attended, Nancy Artist and Peter. The goal of this meeting was to identify the "Trees of Heaven" which are the trees that host the Spotted Lantern Fly. By doing the research for the Borough area, this could help residents learn and treat these trees if they so choose to do so, but to also supply much needed information to residents to help inform them what their options can be. Councilwoman Clarke informed Council there are estimated 22 "Trees of Heaven" in the Borough and she had learned the best time to cut the tree down is in the summer because that is when they are at their weakest. Notification to residents will be determined after some property research is provided. The Community Park does not have any "Trees of Heaven", Mayor Wood has a large property and is working with USDA and Natural Lands to clear trees of questionable health. Councilwoman Clarke contacted Jordan Goldberg, HOA President of Darlington Woods, they have 1 tree infected. Councilwoman Clarke and Councilman Firkser plan on notifying other residents where trees were found.

Proposed Budgets Update – Presented by Pro Tem Lim:

Pro Tem Lim informed Council the Budget Hearing Date of December 7th, 2020 is approaching. Due to Re-assessment appeals that are pending, the property tax and fire tax is still being determined. If anyone has any questions or concerns, please contact the Finance Committee.
