Letter from the Mayor

Hello and Happy Spring, Chester Heights!

It is my pleasure as Mayor and Chair of the Communications Committee to bring you this edition of our twice-yearly newsletter. People ask me all the time- “how much time do you spend being the mayor?” I can say for certain that bringing this content together takes me 10-20 hours in total. Once it’s submitted and drafts are sent back to me, I have 2-3 trusted copy editors that proofread and suggest edits. It’s no small feat bringing you all content that is informative, engaging, and newsworthy. Our committee is always open to suggestions for content and articles that you want to read. Our advertisers and sponsors pay for the printing, the Borough only pays mailing fees; so please support the local businesses and advertisers- without them, this newsletter would not be possible.



In this edition, you will meet our new and returning Council members and mayor; find out what’s new with the Chester Heights Fire Company, read Rachel Kohl Library news, get updates on what is coming up in the Borough and opportunities to get involved.

Now that I am no longer a Councilperson and I no longer have voting rights (except for the unlikely event of a tie), I will be reporting on what Council is doing, deciding on and addressing from a neutral standpoint. Please follow us on the Borough Facebook page that I manage and sign up to receive newsworthy borough emails (send your info to info@chesterheights.org to get on the email list).

In my term as mayor, I have set two high-bar goals for myself and our residents. To begin, I am committed to bringing VOTING back to the confines of our Borough. I don’t think any voter in Chester Heights likes having to go all the way to the GVMS to cast a vote. I am scouring the borough and reaching out to those who have locations that might be suitable to the County Bureau of Elections to hold elections back in our own borough. The ultimate decision is at the County level. I am committed to this goal.

The second, more long-term goal I have set for myself and our residents is to plan for and find a permanent home for the Borough that includes an office, meeting space and storage requirements. Pre-pandemic, we were squeezing borough officials, residents and staff into our space connected to the fire house. We also have a storage unit for additional files, decorations, and supplies. Currently, we are holding public meetings in the Village of Valleybrook Clubhouse. While the space there mostly serves our purposes and we are very appreciative of its availability, the acoustics are difficult, it is not technically ADA compliant, and the restrooms are on the lower level; we also are paying a nominal rental fee each time we need it. COVID and the resulting spacing requirements brought into sharp focus that the borough needs more room to accommodate our growing population and needs. When we began our agreement with the Fire Company to rent 1200 square feet, we had one employee. We now have a total of six paid staff and/or professionals. This is a long-term goal because it will take time to buy or build and then customize a space that suits all our needs. Also, getting to that point will mean we will need to start a capital fund, apply for grants and get community input. It may not happen when my current term is expired in four years. However, I will be committing a large portion of my mayoral time into working towards reaching

this goal. Our surrounding, albeit larger, municipalities began this process over 20 years ago; we are playing catchup in the respect of having a borough space to suit our needs.

If you have any questions about living here, don't know where to find answers to your questions or have suggestions as to how your local government can serve you better, my ears are always open. I can be reached at mayor@chesterheights.org. If I don't have an answer or solution, I will work to get one for you. I thank you for your trust in my ability to serve you well and will do my best to meet and exceed expectations!

Generous Donation to the Rachel Kohl Library

August 10, 2021

The Rachel Kohl Community Library in Concord Township was the beneficiary of a \$203,000 donation from Lee Greskiewicz and her brother Ed Wiley on behalf of their parents, Wilbur and Paralee Wiley. Lee Greskiewicz has been a resident of Chester Heights for 33 years. Ed also resided in Concord Township and Chester Heights Borough for many years. The presentation of the check was attended by Lee, her brother Ed, Library Director Susan Sternberg, Chester Heights Library Board member Debbie Miller, several other members of the Library Board, and Councilwoman Susan Clarke.

Lee's parents, Wilbur W. and Paralee M. Wiley lived in Concord Township and Chester Heights Borough from 1967 until they retired to Granite Farms Estates about 15 years ago. Both were avid readers and members of the Rachel Kohl Community Library. Lee's mother was a teacher at the old Concord Elementary School for 20+ years. Her father was a retired Air Force officer who served 20+ years in the service. Then he taught at Delaware County Community College for another 20+ years. He was instrumental in developing their CAD (computer aided design) program.

The library, which is in Concord Township, serves 5 municipalities and has 14,000 card holders. The library is not fully funded by the communities it supports and depends on donations for 40% of its budget. As the population of the Glen Mills area has exploded, so has the use of the library and the need for more space.

The library had been looking to apply for a Keystone Grant for Public Libraries to expand the facility. The grant however requires matching funds. This donation from the Wiley family will provide the library with the matching funds needed to get the grant. Therefore, the timing of the donation was very fortunate. IF the library is awarded the grant, the bequest and grant would be used to expand the library to include a dedicated children's section. If not awarded, the library will hold the bequest and initiate a capital campaign to get the additional monies needed for expansion. The library is considering naming the additional space after the Wiley family.

We humbly invite you to remember the Rachel Kohl Community Library in your will. A bequest gift can be a way to create a lasting legacy that supports the cause you care about. Please consult your estate planner or tax advisor to add the library as a beneficiary.

Comprehensive Plan -

Definition, history, where to find the most recent, and upcoming process

Our last Comprehensive Plan was adopted in 2013. The goal of this Council is to have that plan updated in 2023. That means the long and involved process of creating an updated Comprehensive Plan will begin in this year. As was done ten years ago, we hope to accomplish this with the aid of grants and specialist organizations. The most recent Comprehensive Plan can be found on our website.

You might be reading this and thinking “what is a Comprehensive Plan?” *A comprehensive plan is a long-range planning tool used to guide the future growth and development of a community. It expresses a community’s vision and goals for the future, sets forth strategies and recommendations to achieve them and a plan for implementing them. Comprehensive plans address to what uses land in a community should be put, how the movement of people and goods should take place, how housing should be provided and maintained, how the community should provide services to its citizens and how the community should interact with neighboring communities. This plan, once adopted by Chester Heights Borough, will serve as a guide for Council’s future decisions concerning development and redevelopment, as well as a guide for implementing ordinances and programs.*

There will be a task force named, public meetings, a public survey and more as this process continues. If you read the Letter from the Mayor, planning for a larger and permanent home for the Borough office will be included in this. Please don’t ignore communications from the Borough. Without your input, any plan that is adopted would be incomplete! We expect this process to take 18-30 months in total.

It is a great time to become part of the Riddle Village community and enjoy the excitement that is happening.

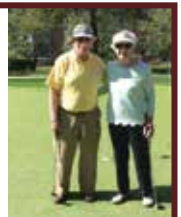

MESSAGE FROM OUR LEADERSHIP

As we begin the new year, we wanted to recap the efforts and commitment of our members to the citizens of Chester Heights Borough and the surrounding communities in 2021.

The Chester Heights Fire Company is truly an **“all-volunteer”** fire company. There are no paid drivers, no per-call stipends or any type of monetary incentives for our members. The time each member invests is at their own will. That type of commitment only comes from a deep sense of service and accomplishment each member understands.

It's not just about calls for service. The commitment encompasses the time invested in training, equipment and station maintenance and the administrative duties that keep the organization functioning and its members well prepared to handle those calls for service. We are proud to present a snapshot of the activity and commitment our members invested in 2021.

OUR COMMITMENT TO TRAINING

The Fire Company conducted **43 organized training activities** in 2021. These activities are typically held on Thursday night but also include some weekend sessions. We do not train on the first Thursday night of each month. That night is reserved for our Company Meeting and our Engineer's Night, where all the equipment is checked and serviced.

In addition to the organized training activities, our members invest personal time in attending formal training through different training facilities and organizations. Upon

completion of the classes and a variety of written and hands-on evaluations, this training typically results in either a Pennsylvania State or Nationally Recognized certificate. Our members invested **1,278 hours in Certified Training in 2021.**

One of the highlights of this past year is the number of members with an Emergency Medical Technician certificate doubled and 80% of our members are now certified to the Water Rescue Operations Level or the Technician Level.

2021 SERVICE CALLS

The Fire Company responded to **14 Working Fires** in 2021. A working fire is a structural or building fire where at least one hose line has been utilized in the extinguishment of a fire. That equates to having 1 Working Fire for every 5 Building Fire calls the Company responded to.

The Fire Company responded to **3 Vehicle Extractions.** These are vehicle accidents where extrication tools were utilized in order to free a passenger.

Probably the hardest commitment to document or quantify is the time and effort our members put into the administrative and support functions necessary for fluid operations. If we were to attempt to assign hours to these activities, we would put the commitment as high as any other category.

FIRE COMPANY FINANCES

Impact of Real Estate Re-Assessment

The Chester Heights Fire Company operation follows a 20-year long-range financial plan updated yearly to incorporate changes in funding and costs. Just like in your household, even with careful planning, we cannot avoid being affected by the changing economy. After the county-wide re-assessment, new housing construction in the borough reduced the average household fire tax bill and left the overall tax base income neutral. Our long-range plan had included income from the new construction. This change has led to a reduction in our anticipated fire tax revenue that would have covered most, if not all, of our increased costs. We are analyzing that effect on our long-range plan. The analysis is delayed due to pending assessment appeals impacting last year's receipts by a potential 7% with no current predictable outcome on those appeals.

Grant Funding

We continue to explore available funding sources, including grants to keep the increases in costs from hitting individual taxpayers. Over the last year, the Fire Company has finalized the FEMA Air-Pack Grant awarded in 2019 for \$103,609 and received a grant from Energy Resources Partners in the amount of \$22K for the purchase of gas meters and Nomex hoods. We were also awarded a \$17K grant for a specialized washer and dryer for our fire gear. These new machines allow us to not only save money on sending gear out to be cleaned, but also reduce our downtime, and help extend the life of the gear resulting in less frequent purchases. We continue to apply for and receive an annual loan mitigation grant of \$15K from PEMA that helps reduce the debit payments on our building and equipment purchases.

Increasing Costs

There is no secret that fire protection services cost money. As the only service that the borough is required to provide under the borough

code, it is always one of the largest budget line items. Like you we have been affected by rising gas prices, utility rates, and equipment costs. We anticipate that the continued increases in our operating costs will lead us to request a fire tax readjustment for the 2023 tax year. This could result in an annual average increase of \$10 per homeowner .

Commitment to Financial Transparency

We realize that a conversation about funding is always a delicate subject that's why our leadership is committed to financial transparency. We continue to provide the borough with our financial reports on a quarterly basis, which are subject to the PA Right to Know Law (Open Records).



75TH ANNIVERSARY



This year marks the 75th anniversary of the 1947 incorporation of the Chester Heights Fire Company. The fire company was established in 1946 (a year earlier) to fulfill a judge's mandate issued to the Borough of Chester Heights noting that their incorporation status was contingent on the establishment of their own fire protection service. Today that mandate to provide fire services is regulated by the borough code.

The history of the company is really a history of the people of this town and our volunteers, which is why we cannot wait to celebrate this anniversary with you.

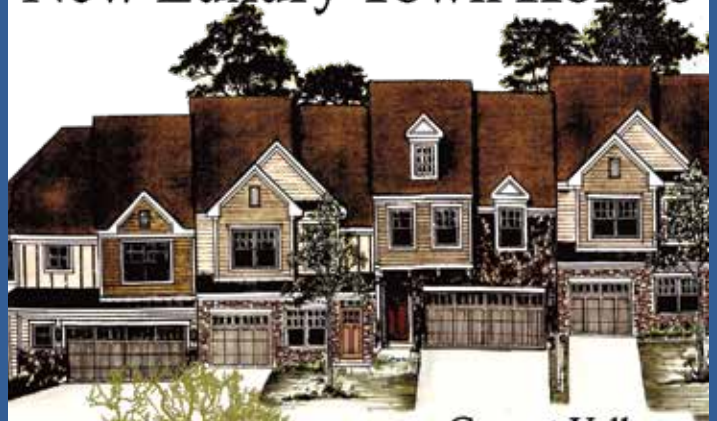

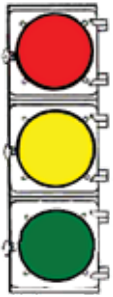
